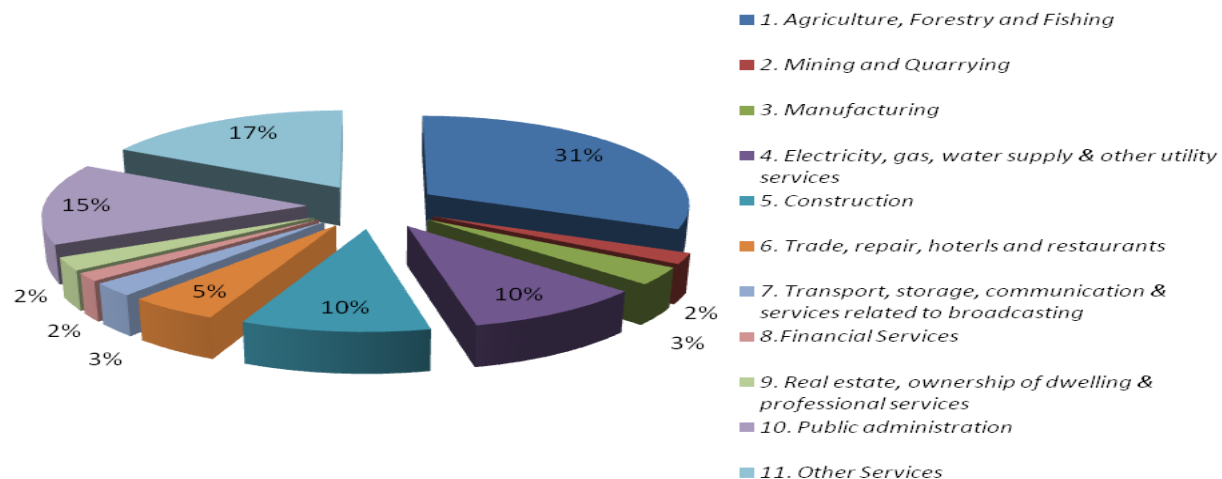

INTRODUCTION

1.01 The Directorate of Economics and Statistics prepares and publishes estimates of State Domestic Product of Arunachal Pradesh, for both at current and constant prices. The publication incorporates Provisional (P), Quick (Q) and Advance (A) estimates for the years 2017-18, 2018-19 and 2019-20 respectively and Revised (R) estimates for the years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 & 2016-17 with the new base year 2011-12. These estimates reflect the economic situation of the state and indicate the level of its growth and development over a period of time.

1.02 The new series i.e. 2011-12 as base year, the GSDP estimates are being prepared at Market Prices. Earlier the GSDP with 2004-05 base years was being compiled at “factor-cost”. As such, statistical comparisons between the old and new base year cannot be drawn for GSDP from 2011-12 onwards.

1.03 The State Domestic Product is defined as the aggregate of the economic value of all final goods and services produced within the State in a year. It is to be noted that while computing State Income only such of the economic goods and services that can satisfy socially accepted human wants are considered.

1.04 The estimates of Gross and Net State Domestic Product (GSDP and NSDP) from 2011-12 to 2019-20 (A) are computed with new base year revision methodology and usage of latest data sources as prescribed by the National Accounts Division of National Statistical Office (NSO), Ministry of Statistics & Programme Implementation, Govt. of India. For the purpose of estimation of SDP, the state economy is divided into 11 sectors with sub-sectors under three Broad Industry Groups (Economic Sectors).

1.05 The Gross State Value Added (GSVA) is worked out for each sector separately. An intermediate input, FISIM (Financial Inter-mediation Services Indirectly Measured) is allocated to some user industries. The FISIM, so allocated, is deducted from unadjusted GSVA to get adjusted GSVA and then finally aggregated to get total GSDP. The Net State Value Added (NSVA) in respect of a particular sector is computed by subtracting consumption of fixed capital (CFC) of concerned sector from the GSVA of that sector. But in case of sectors/sub-sectors like Public Administration, Water Supply and major part of other services, NVA is first worked out from the budget document and then CFC is added to get GSVA. After this exercise, NSVAs of all the sectors are aggregated to arrive at total NSDP.

1.06 CFC is a part of the gross product required to replace fixed capital used up in the process of production. The estimates of CFC at current and constant prices are provided by the National Accounts Division of the Central Statistics Office of MOSPI.

1.07 The estimates of total GSDP and NSDP are divided by the estimated mid-financial year population of the state to get per capita GSDP and per capita NSDP respectively.

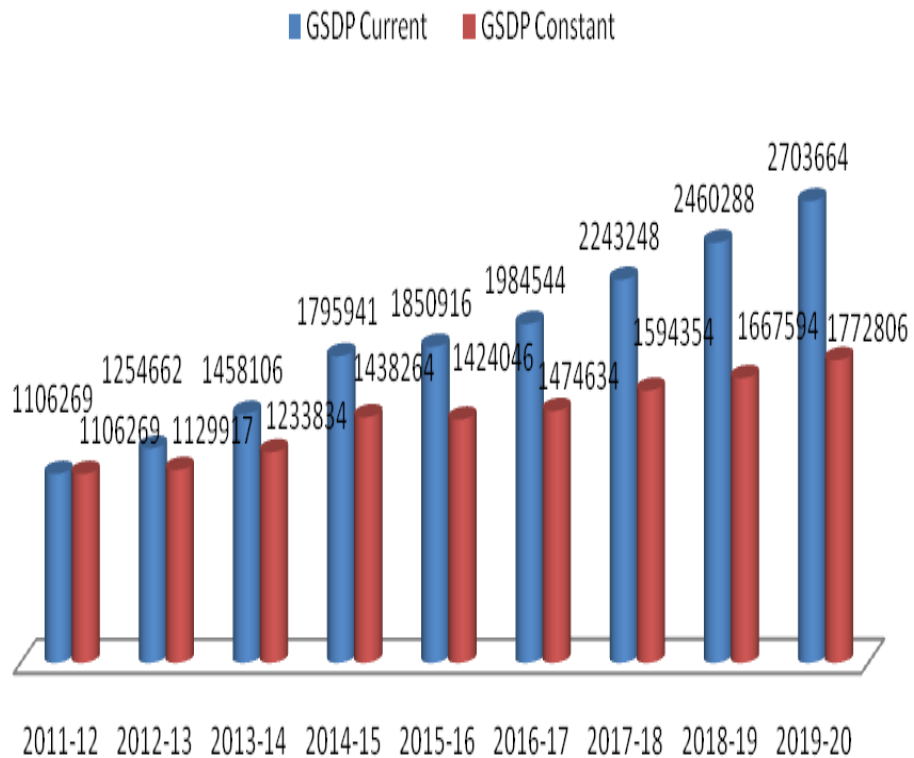
1.08 The estimates of Gross Domestic Product are prepared for each sector separately by adopting one or more of the three alternative methods. Ideally each approach must give the same value. **Production or Value Added Approach** accounts for the value of all goods and services produced within the state during the year after deducting the value of intermediate inputs. The **Income Approach** determines the income generated from economic activity within the state. In this method, the aggregate income is considered to be the total of four factor incomes i.e. rent, salaries & wages, interest and profit. In **Expenditure Approach**, estimation is done considering all the expenditures in the state.

1.09 For estimation of SDP, Product Method is used in all the producing enterprises of Primary Sector and manufacturing enterprises of Secondary Sector, the Expenditure Method for Construction Sector and Income Method is used for the rest of the sectors/sub sectors.

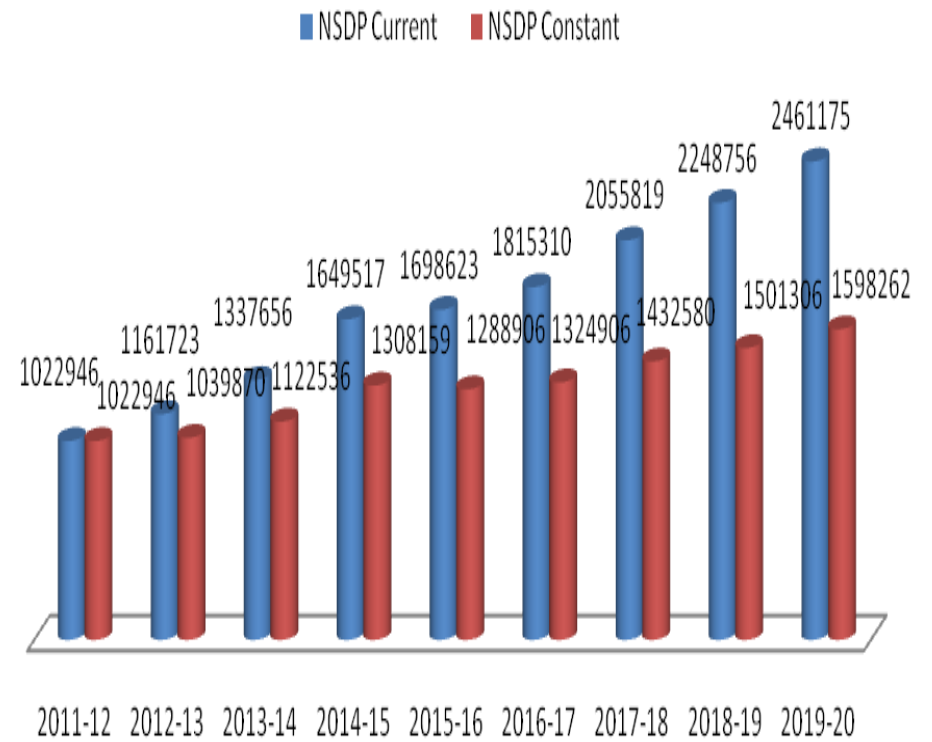
2. REVIEW OF ESTIMATES OF STATE DOMESTIC PRODUCT (S.D.P.) :

2.01 The estimates of Gross and Net State Domestic Product of Arunachal Pradesh and their per capita at current and constant (2011-12) prices for the years from 2011-12 to 2019-20 (A) are presented in tables 2.1 and 2.2. At current prices, GSDP is estimated at Rs. 2460288 lakhs in 2018-19 as against Rs. 1106269 lakhs in 2011-12 whereas at constant prices, GSDP is estimated at Rs. 1667594 lakhs in 2018-19. It reveals that the growth of GSDP during the years from 2011-12 to 2018-19 is 222.40% at current prices and 150.74% at constant prices. In 2018-19, Net State Domestic Product (NSDP) is estimated at Rs. 2248756 lakhs at current prices and Rs. 1501306 lakhs at constant prices as against Rs. 1022946 lakhs in 2011-12. The growth of NSDP during the years from 2011-12 to 2018-19 is 219.83% at current prices and 146.76 % at constant prices.

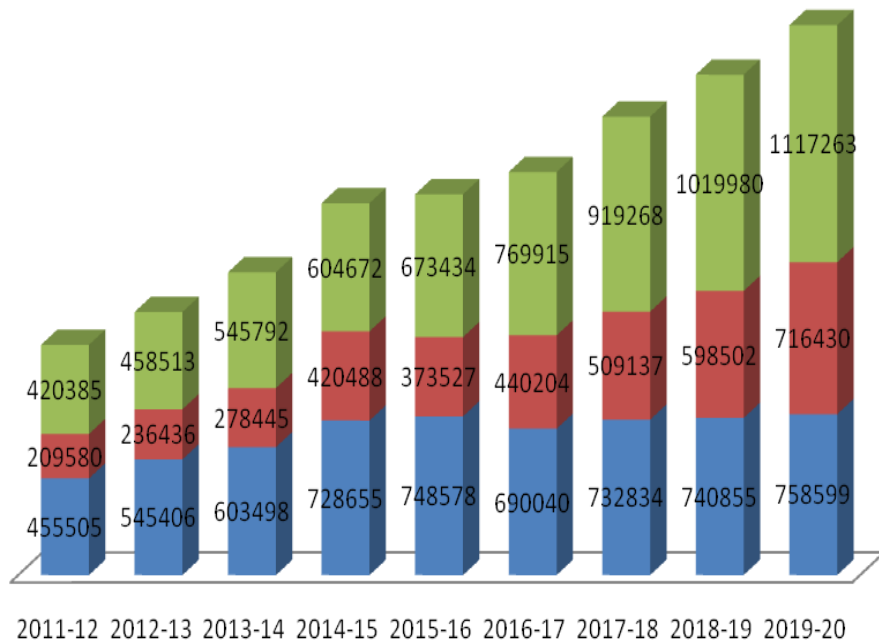
3. GSDP/NSDP BY ECONOMIC ACTIVITY :

3.01 Economic Activity-wise GSDP and NSDP of Arunachal Pradesh at current and constant (2011-12) prices for the years from 2011-12 to 2019-20(A) are shown in tables 3.1 to 3.4. The per capita GSDP of Arunachal Pradesh for the year 2018-19(Q) is estimated at Rs. 152718 at current prices and Rs. 103513 at constant prices.

3.02 The Per Capita State Income (i.e. per capita NSDP) of Arunachal Pradesh during the year 2018-19(Q) is estimated Rs. 139588 at current prices and Rs. 93191 at constant (2011-12) prices as compared to the Per Capita National Income of India is Rs. 126521 at current prices and Rs. 92085 at constant (2011-12) prices. The Per Capita State Income shows that the growth during the years from 2011-12 to 2018-19 (Q) is 191.04% at current prices and 127.54 % at constant prices.

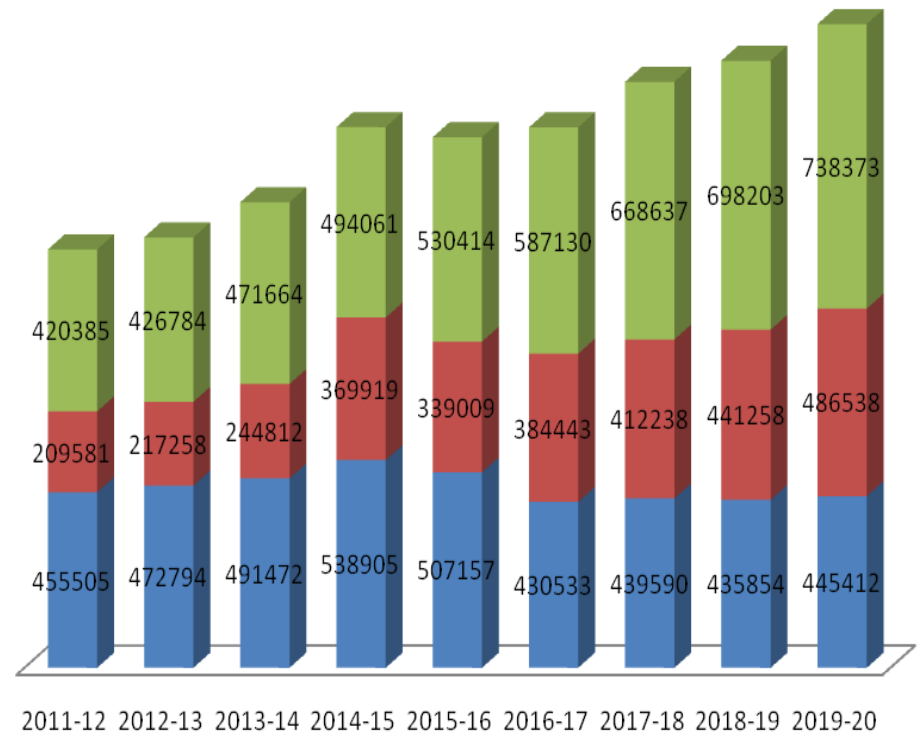
3.1 Contribution of Broad Economic Sector in GSDP at Current Prices (Rs. In Lakh)

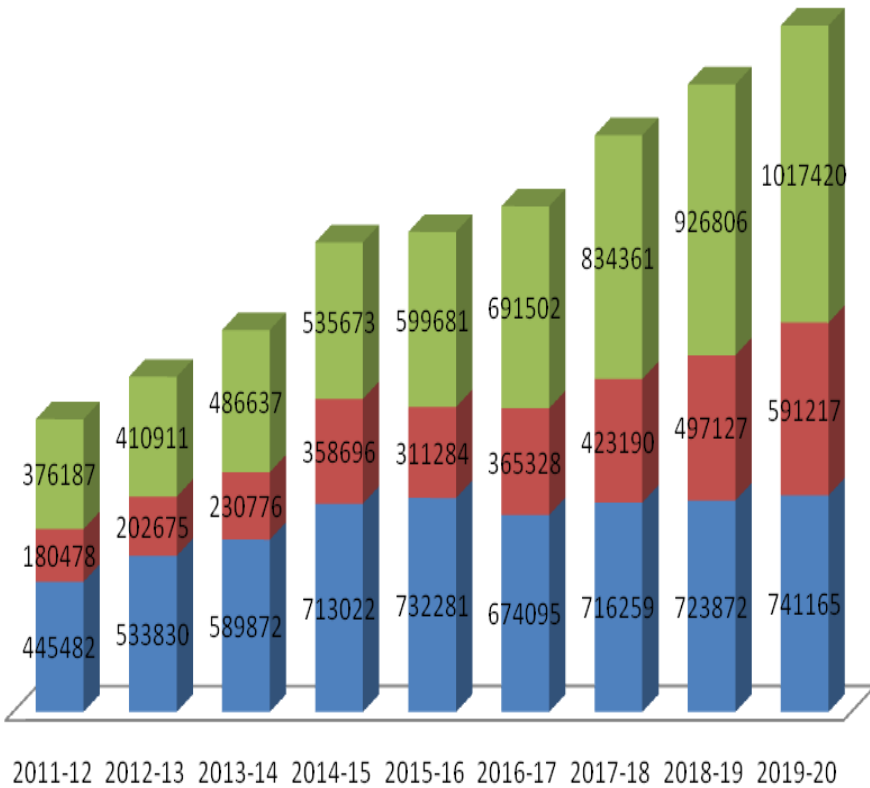

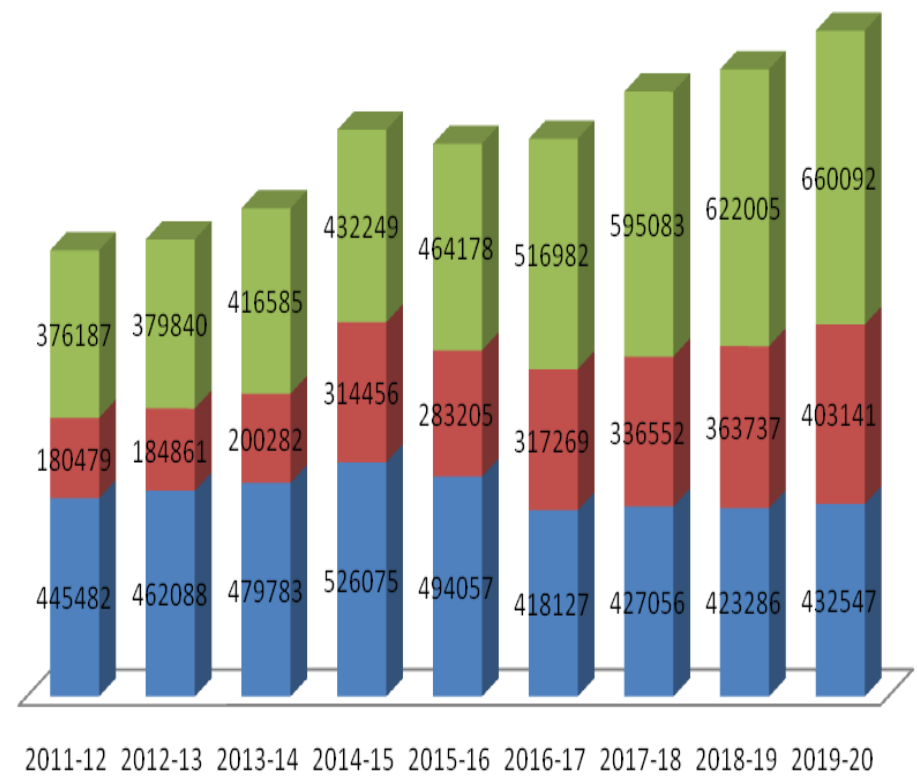
3.3 Contribution of Broad Economic Sector in NSDP at Current Prices (Rs. In Lakh)

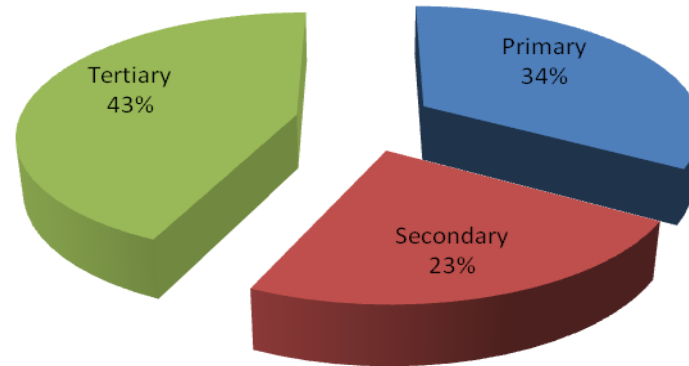

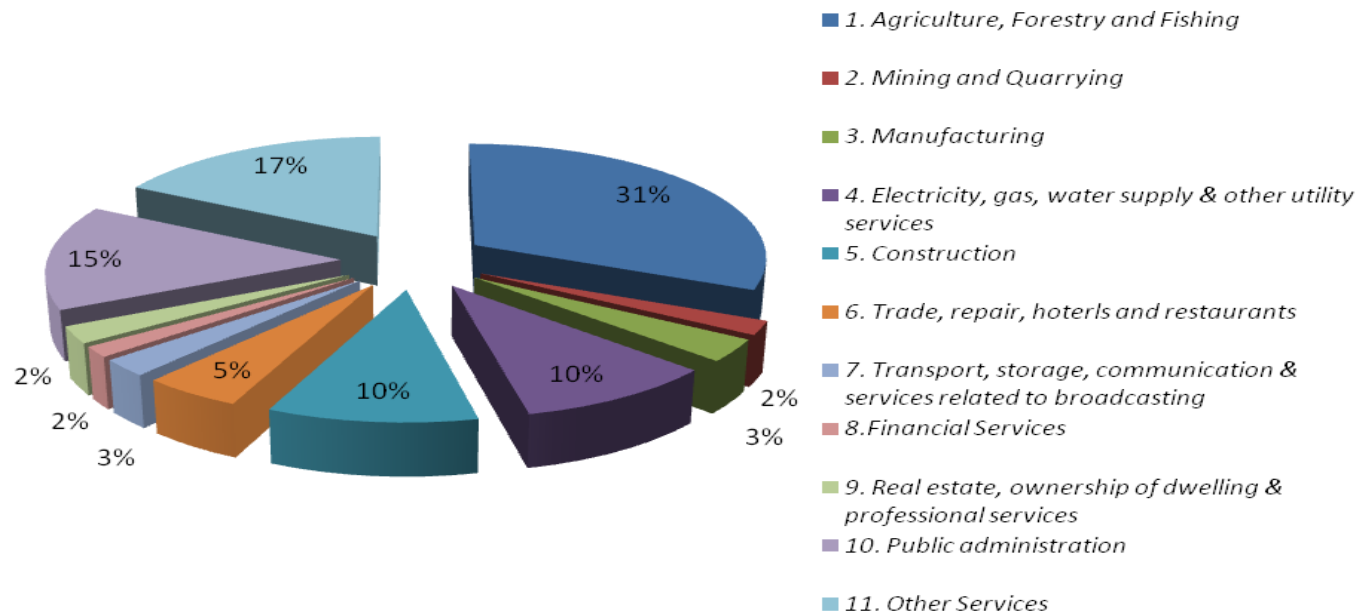
4.01 The contribution of economic activities in GSDP and NSDP of Arunachal Pradesh at current and constant (2011-12) prices during the years from 2011-12 to 2019-20 (A) is shown in Tables 4.1 to 4.4. It reveals from the estimates at current prices for the year 2018-19(Q) that the contribution of Agriculture, Industry and Service sectors to total GSDP is 31.40 %, 25.37 % and 43.23 % respectively and their contribution to total NSDP is 33.70 %, 23.15 % and 43.15 % respectively. The estimates at constant prices for the year 2018-19(Q) reveal that the contribution of Agriculture, Industry and Service sectors to total GSDP is 27.67 %, 28.01 % and 44.32 % respectively and their contribution to total NSDP is 30.04 %, 25.81% and 44.14 % respectively.

4.02 The contribution of Forestry & Logging in GSDP / NSDP is found to be the highest in primary sector. The highest contribution in Secondary and Tertiary Sectors is from Construction and Other Services and Public Administration respectively.

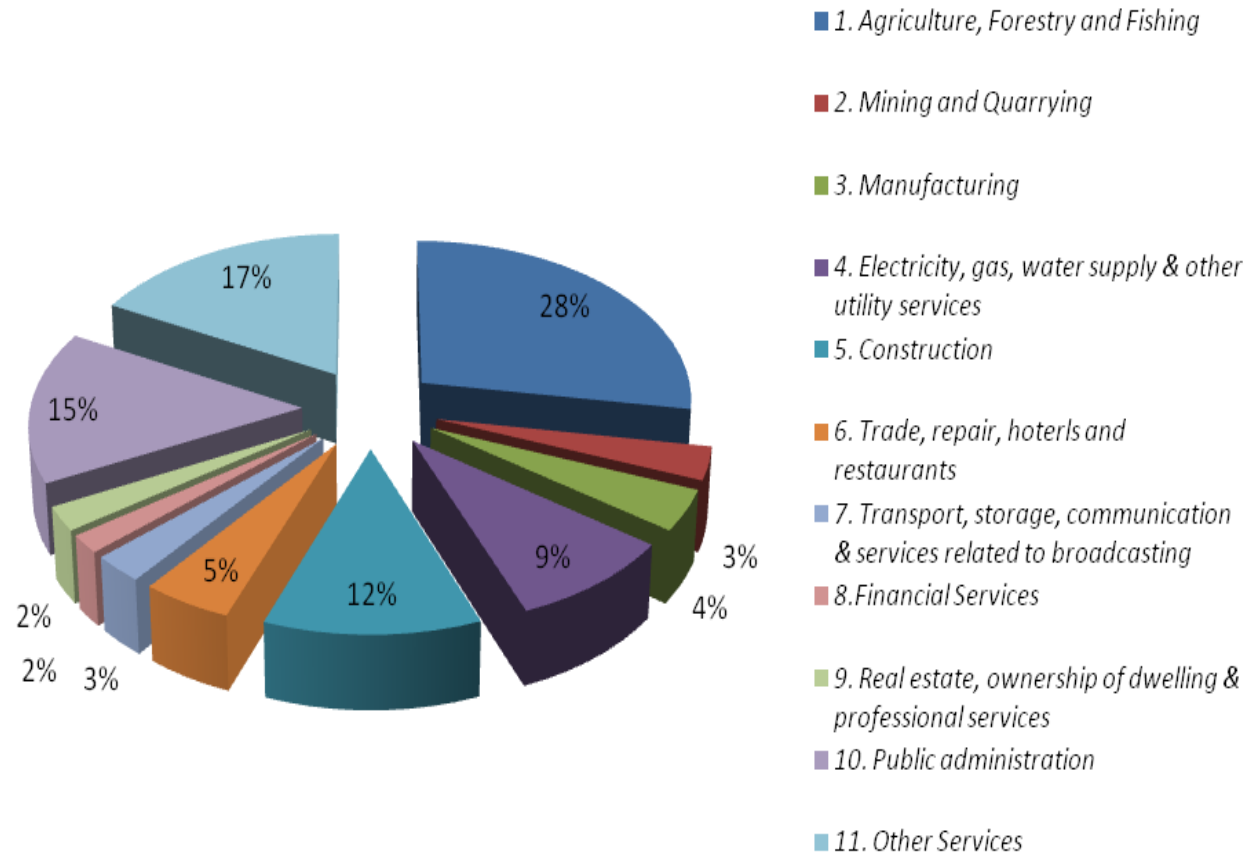
4.1.1 Percentage share in GSDP of Arunachal Pradesh by Broad Economic Sector at Current Prices during the year 2018-19



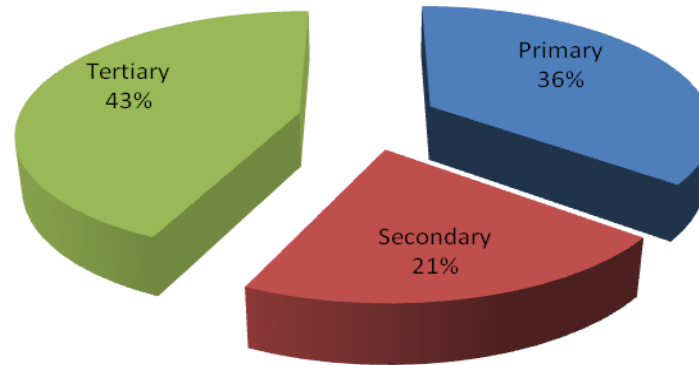
4.1.2 Percentage share in GSDP of Arunachal Pradesh by Industries by Broad Economic Sector at Current Prices during the year 2018-19



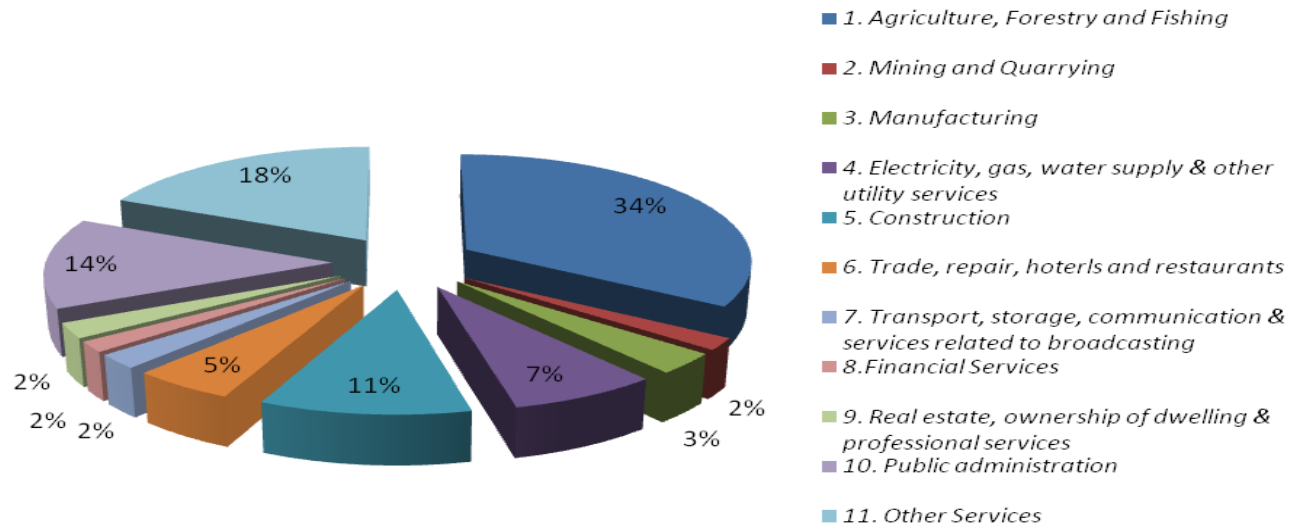
4.2 Percentage share in GSDP of Arunachal Pradesh by Industries at Constant (2011-12) Prices during the year 2018-19



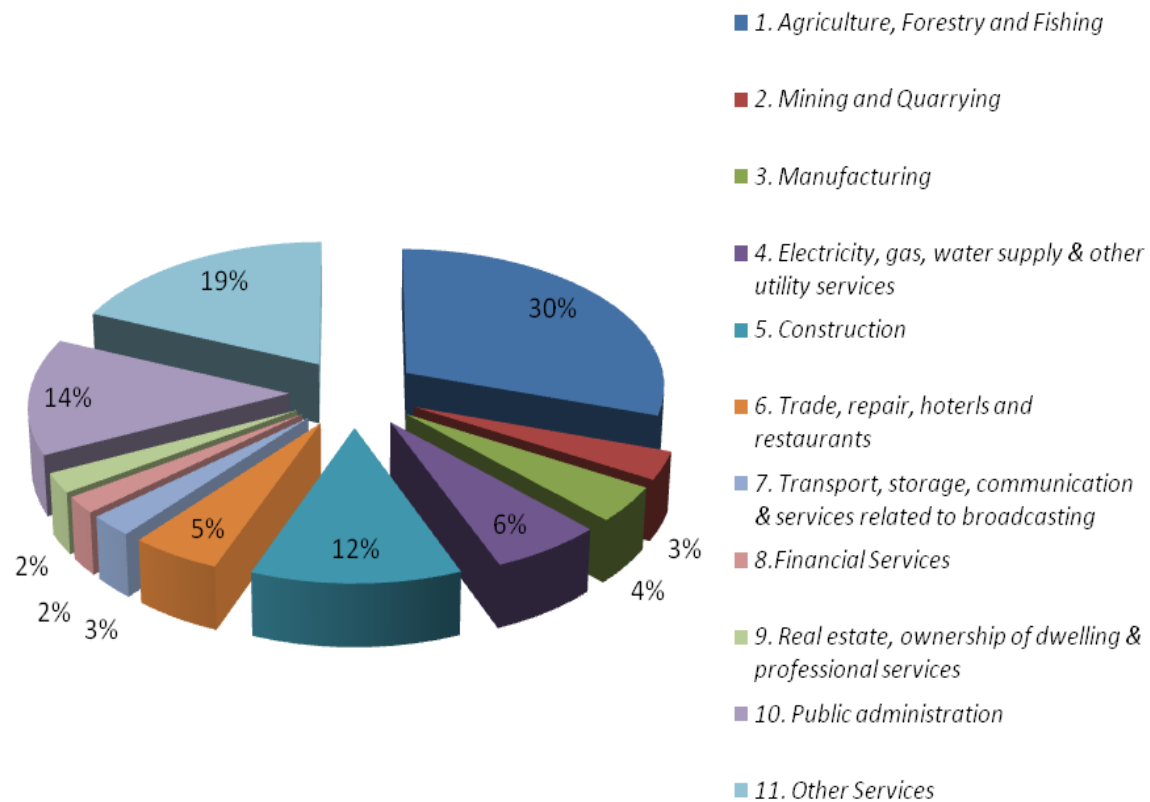
4.3.1 Percentage share in NSDP of Arunachal Pradesh by Broad Economic Sector at Current Prices during the year 2018-19

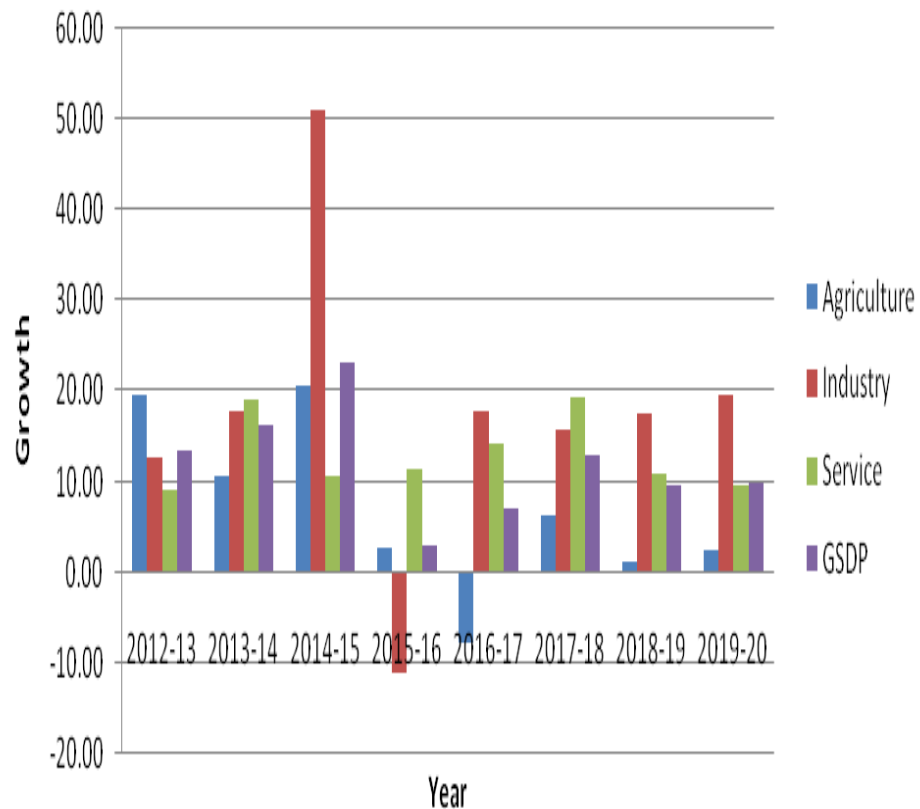
5.01 Tables 5.1 to 5.4 depict percentage change over previous year in GSDP and NSDP of Arunachal Pradesh during the years from 2011-12 to 2019-20(A) at current and constant (2011-12) prices. Sector wise growths on GDP are mentioned below.

5.02 Agriculture : The “agriculture, livestock, forestry and fishing” sector GSDP growth during 2018-19(Q) is decrease by -0.85 percent as compared to a growth of 2.10 percent during 2017-18 at Constant Prices. The production and price information furnished by the Department of Agriculture, Horticulture, Animal Husbandry, Agriculture Marketing, Forest and Fisheries have been used in compiling the estimate of GDP for Agriculture sector.

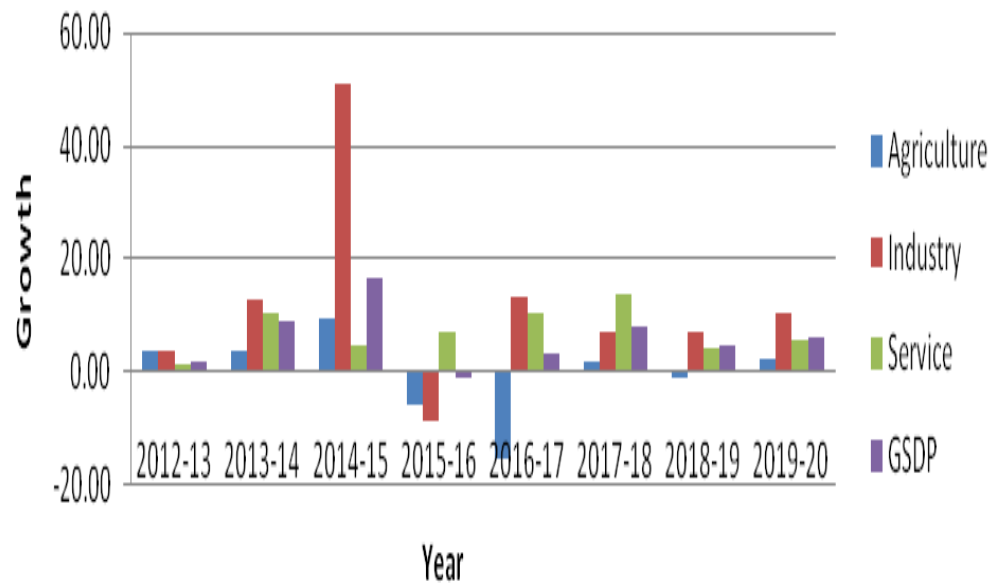
5.03 Industry : Industry sector (comprising Mining & Quarrying, Manufacturing, Construction and Electricity, Gas, Water Supply and Remediation Services) is slight decrease by 7.04 percent during the year 2018-19(Q) as compared to a growth of 7.23 percent during 2017-18 at Constant Prices.

5.04 Services : In Services Sector the GSDP during the year 2018-19(Q) is decrease of 4.42 percent as compared to a growth of 13.88 percent during 2017-18 at Constant Prices.

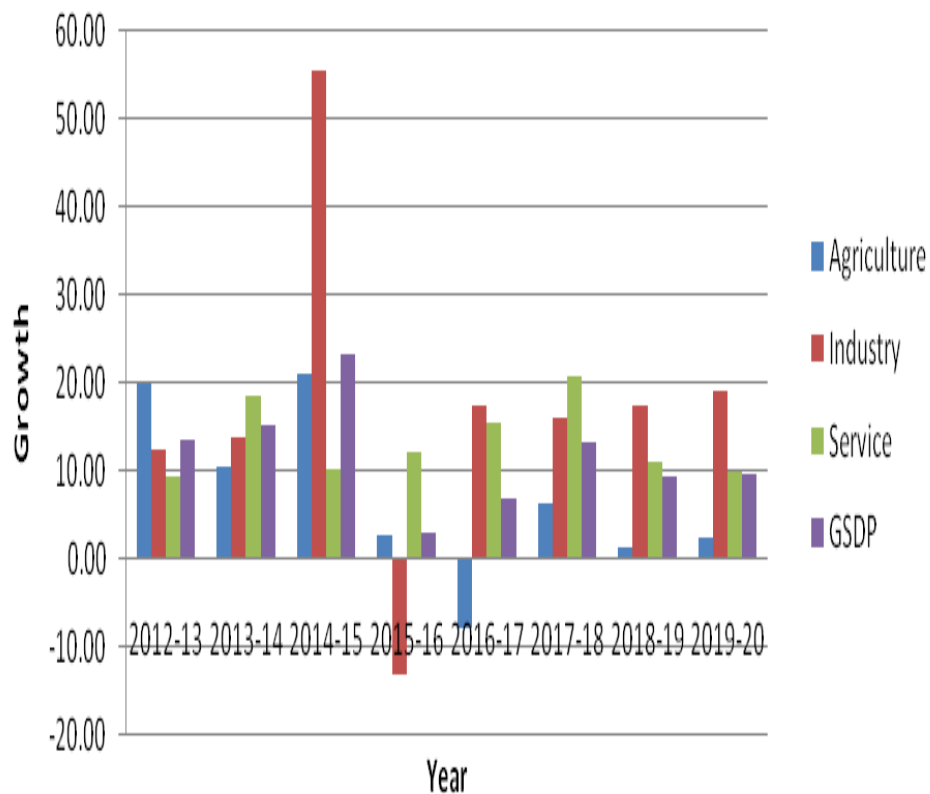

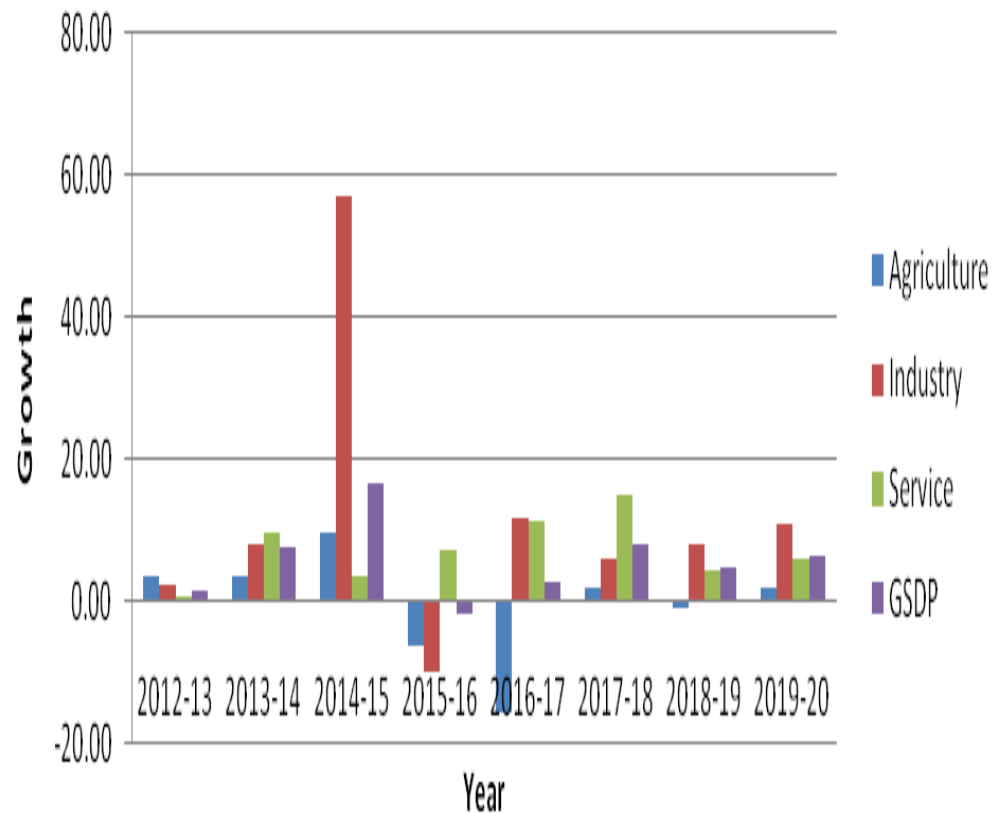

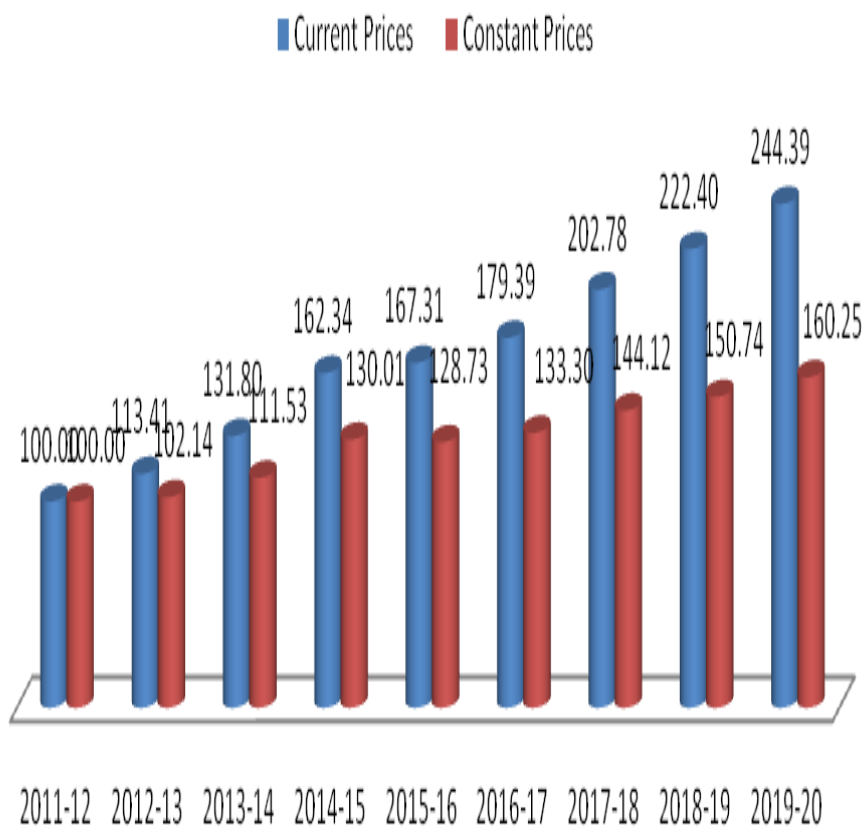

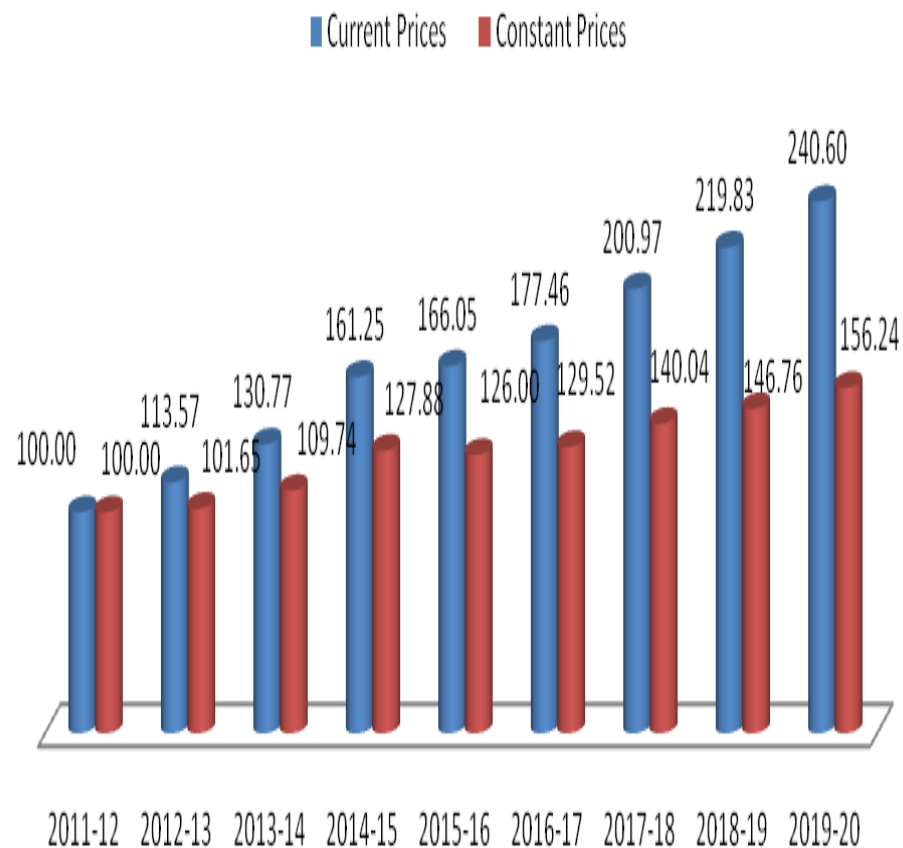
6. INDICES OF GSDP/NSDP BY ECONOMIC ACTIVITY:

6.01 Tables 6.1 to 6.4 depict indices of GSDP/NSDP by Economic activity at current and constant prices for the years from 2011-12 to 2019-20(A). Indices of GSDP 222.40 and NSDP 219.83 at current prices have shown increase of 9.68 % and 9.38 % respectively during 2018-19(Q) over the previous year. The indices of GSDP 150.74 and NSDP 146.76 at constant prices have shown increase of 4.59 % and 4.80 % respectively during the year 2018-19(Q) over the previous year.

7. REVIEW OF ESTIMATES OF BROAD ECONOMIC SECTORS

7.01 Broad Economic Sector-wise quick estimates of GSDP for 2018-19 have been presented in Table 7.1. The overall GSDP growth for the year is 9.68 % at current prices and 4.59 % at constant prices.

7.02 Table 7.2 shows Broad Economic Sector-wise quick estimates of NSDP for 2018-19. The overall NSDP growth for the year is 9.38 % at current prices and 4.80% at constant prices.

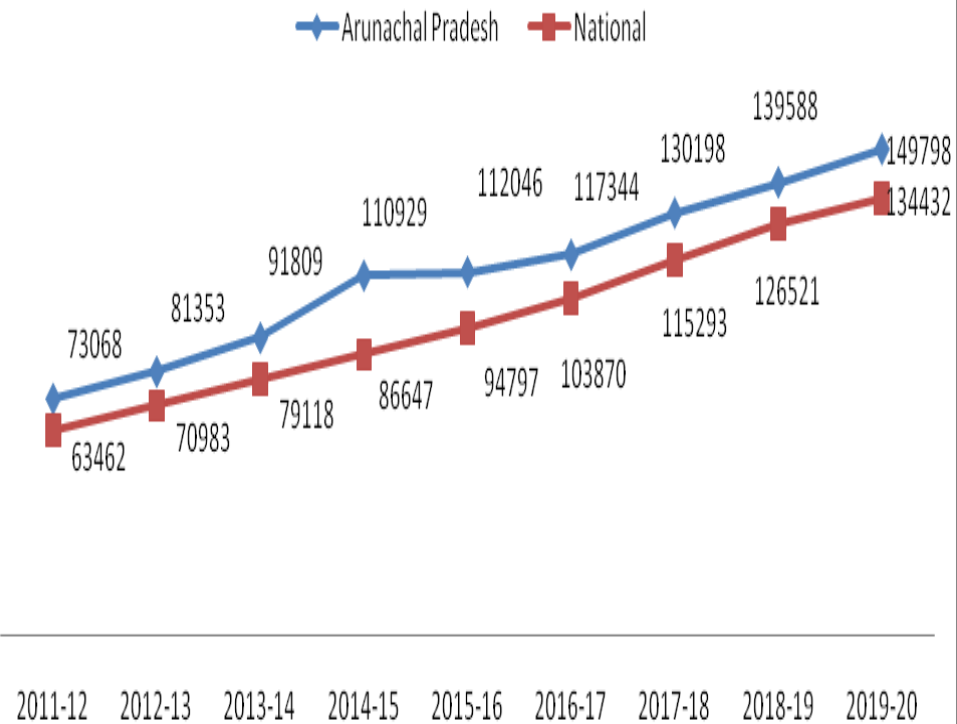

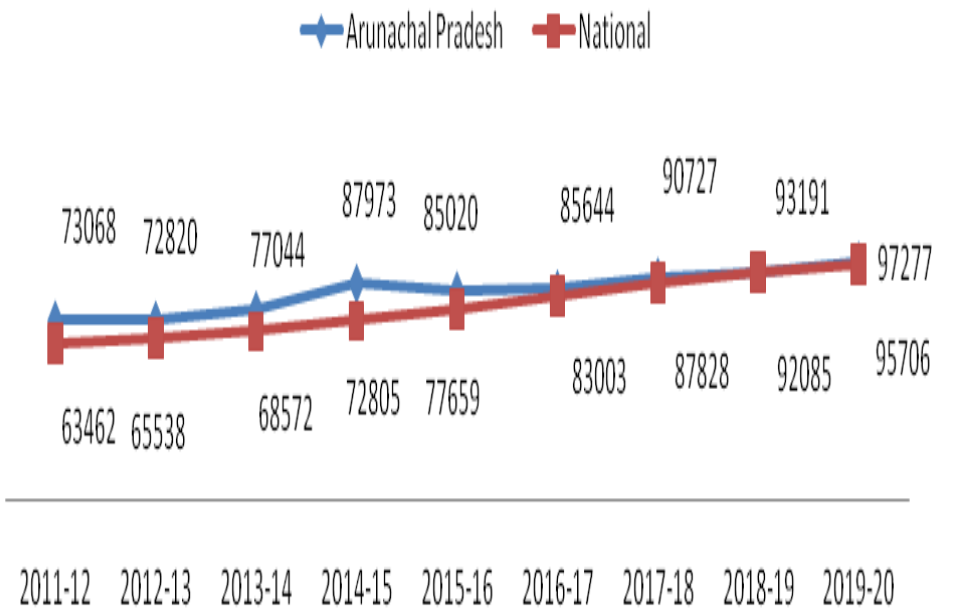
